The client can experience interruption in service due to unforeseen circumstances at which time A Loving Sitter.com will make the effort to render service if possible.

A Loving Sitter.com will charge a fee of \$_____ per hour for the said service above which will be due when the service is rendered. Any request for services given 24 hours or less will be billed at an additional \$5 per hour. All services will be charged to the client's credit card that is given to us on signing the contract. A receipt of any charges will be provided to the client after each billing to their charge card. A \$50 nonrefundable annual membership fee will be charged to you upon signing the contract.

Any termination in services requested for a specific period of time (full-time or part Time) must be submitted in writing with a two weeks notice. Termination without proper notice will result in A Lovingsitter.com charging the client at the agreed hourly rate according to the hours and dates that was requested for thirty days. If the requested service was for less then thirty days then the entire length of the contract will he charged.

In the event the client has any concerns or becomes dissatisfied with the services of the sitter, the client must notify A loving sitter.com immediately in writing. A loving sitter.com will then take the appropriate actions needed (either discussing the concerns with the sitter in hopes of improvement, or removing the sitter from the case if deemed necessary and finding a replacement within 14 days - depending on the preference of the client). If the client is still unsatisfied with the replacement, the client must then give A loving sitter.com a two week written termination notice.

Clients using A Loving Sitter.com for Occasional services must cancel request made 48 hours before the scheduled time. Cancellation less than 48 hours will be billed at 4 hours at the regular rate.

A time ticket will be provided to the client for their signature after service is rendered.

The client agrees not to hire indirectly or directly the sitter/companion for a period of 180 days after his/her assignment. In the event the client hires the sitter of A loving Sitter.com there will be a \$5000.00 liquidation fee assessed to the client. The client will be responsible for attorney's cost and/or court fees of A loving Sitter.com in collecting legally.

All clients are required to provide their own means of transportation with added drivers coverage to their insurance policy when sitters are needed to escort children to/and from school, activities, appointments, etc.
